#### Foreword

Throughout another very busy year the Forum's staff has remained focussed on their respective work plans and their high level of productivity continues to impress the voice of children and young people with additional support needs upon those who serve them throughout the Highlands. The comments in the main text are a great testament to their efforts and I'd like to record the Committee's thanks for their dedication and commitment.

The Forum's founders insisted that the management committee should be parent-carer led. Our work being directed by a mix of carers who access services and understand at first hand both the joys and challenges of raising children and young people with additional support needs and of interested professionals is vital. In addition, parent-carers bring life experience and professional skills which add further value and enhance how the staff are guided and supported.

It is increasingly difficult to find parent-carers to undertake such unpaid work, not just with the Forum but across the voluntary sector. Is this a sign that carers are under more pressure because of their caring responsibilities, or is it their need, desire or ability to gain employment that is reducing their capacity

> to engage with voluntary groups? The Forum has the advantage of a membership that is scattered across Highland giving us a strength when we are looking at how children and young people are truly supported in all localities but a challenge when it comes to facilitating members to serve on the Management Committee. In the year ahead the Forum will have to experiment with the use of digital technologies to allow the voices we need to hear

to remain integral to the management of the Forum.

The voice we seek to represent is being heard but the Forum continues to be focussed on making that voice a continuing major driver in policy and practice development.

### LISTENING TO CHILDREN AND YOUNG PEOPLE

#### **Disability Awareness**

Following on from last year's success with their podcast at the Festival of Politics and the film made in collaboration with the Scottish Parliament Media Centre a group of 4 young people with various additional support needs successfully progressed their Disability Awareness campaign by producing a pack of resource materials. Initially sent to all Highland secondary schools, it was enthusiastically championed by the Health and Wellbeing curriculum group and has been uploaded to GLOW, the virtual learning environment, where it will be accessible to all Highland teachers and pupils. The Resource Pack, shown at the January meeting of the Adult and Children's Services Committee in the Highland Council chamber, has also been requested for use in Lincolnshire and Eire. The film and podcast have also been used to support Disability Awareness workshops at Highland Youth Voice conference.

#### Inclusion

■ Inclusion has been the subject of the majority of consultation time this year. This is a major consultation looking at young people's inclusion in all community settings and is a follow on from the Forum's consultation report in 2005. The Consultation Lead has visited 17 primary and 3 secondary schools, 1 Further Education college and 1 special school across 3 diverse areas of Highland, working with 515 children and young people in 18 groups. 24 providers, 2 parent groups, 7 parents, and 9 individual young people with a range of needs have also taken part. The report is underway and should be published in early summer 2013.

#### **Play Highland**

■ The Forum has continued its interest in children's play and the Consultation Lead has worked on the Improvement group and facilitated a workshop at the Play Highland Seminar.

#### **Consultation Workshop**

■ The Consultation Lead developed a 3 hour Consultation Induction Course as an introduction for organisations feeling less than confident to fulfil their obligation to have regard for the views of their young service —users.

Preparatory work has also been done on two projects that will get underway in early summer 2013, these are:

#### **Public Health Consultation**

■ The NHS Director of Public Health's annual report in 2013 is concentrating on Children and Young People's health and wellbeing, the perception of the health services that they receive and their view of the direction in which progress needs to go. The Consultation Lead is working with 4 groups of young people to ensure that the view of young people with additional needs is represented.

#### **Digit Evaluation**

■ HCF has been asked to evaluate the DIGIT project (Dornoch, Invergordon and Golspie In Transition). This involves consulting past attendees, staff members, current attendees and employment/training destinations.

#### SPEAKING TO POLICY MAKERS

- The Forum has used its access to key policy makers and to practice development meetings to take the testimony of children and young people and of their parents and carers into where decisions are made and change is started. The briefings prepared by the Forum on Council papers were shared with politicians of all parties and the points that we have raised have regularly appeared in Council debates. The Forum also delivers a news analysis roughly weekly to politicians, policy makers, managers and members.
- During the year the Forum has lobbied the Highland Council on specific issues such as the implementation of changes in classroom support in Caithness and on its continuing worries about the changes in the Children's Services' Budgets which it believes will lead to a decline in services. The Forum has also been active in investigating NHS Highland issues including Paediatric Services in Lochaber and Child and Adolescent Mental Health services.
